I also understand that being a sponsor is a commitment of time. I will meet with the person I am sponsoring on a regular basis. I will attend the liturgical rehearsal and rites, and other initiation-related events to the best of my ability. I further understand that being chosen as a sponsor is a *lifetime* commitment to be a faithful witness of the Catholic way of life to the individual I am called to serve.
